Following vesting, RSUs will settle automatically into an equal number of shares of Helmerich & Payne, Inc. common stock.

This Form 4/A corrects and restates the number of RSUs determined to be eligible to vest to reflect additional RSUs eligible to vest resulting from dividend reinvestment rights. Such additional RSUs were also omitted from one Form 4 subsequently filed by the reporting person.
