Explanation of Responses:

- These options were granted under the Helmerich & Payne, Inc. 1990 Stock Option Plan (Rule 16b-3) on 12/6/95 at an exercise price of \$28.00, \$14.00 post stock-split, and finally adjusted to \$10.6545 post-spinoff. These options vested over 5 years in 20% increments. The noted date is the date options first vested.

Remarks:

This amendment is filed solely to correct the amount of securities reflected as beneficially owned in column 5 of Table 1. The amount was originally inadvertently understated by 1,000 shares based on the prior incorrect Form 4. No other change is reflected in this amendment from the original Form 4.
