- (3) The price used to determine the number of shares allocated to the insider's account was \$59.35, as well as \$41.04 and \$39.91. The foregoing average prices were used to calculate the phantom dividends of September 1, 2005, June 1, 2005 and March 1, 2005, respectively, all of which dividends are reflected on this Form 4.
