## **ITEM 5. OTHER MATERIALLY IMPORTANT EVENTS**

On January 18, 1994, the District Court of Harris County, Texas dismissed without prejudice the lawsuit styled Theresa Arceneaux, et al. v. Natural Gas Odorizing, Inc., Case Number 93-568602, District Court Harris County, Texas, 165th Judicial District. Prior to dismissal, plaintiffs had sought actual damages of \$500 million dollars and punitive damages of \$500 billion dollars against Registrant's wholly owned subsidiary, Natural Gas Odorizing, Inc.
